In supersession of all previous orders/notifications, the Gauhati High Court Kohima Bench has been pleased to issue the following guidelines pertaining to the mode of functioning of Court, working strength of Officers and Staff, restricted entry of Lawyers etc. w.e.f. 12.07.2021 onwards until further orders.

- All Courts at Kohima Bench shall function in virtual mode as before i.e Single Bench on Monday, Tuesday, Thursday and Friday. Division Bench on Wednesday.
- All types of cases shall be listed except matters pending for hearing. However, hearing matters to be listed if mention is allowed by Hon'ble Court.
- Staff of all Grades who are fully vaccinated except those who are 55 years of age and above shall attend office on every working day.
- 4) Staff of all Grades who have not received any dose or received only a single dose shall attend office every alternate day. The respective section in-charge shall determine the working arrangement of such staff.
- 5) Entry of outsiders shall be strictly prohibited unless specifically directed by the concerned authority or unless a personal appearance is required in a judicial proceeding. Further, no person except the learned Advocates/parties appearing in person, who are to address arguments, shall be permitted in the Court room.
- 6) Bar rooms and canteens shall remain closed.
