No. HC(K)7/06/J-I/\_\_\_\_\_/::: Whereas the Kohima Bench has been functioning in virtual mode only with effect from 26-04-2021 vide Notification dated 22<sup>nd</sup> April, 2021 which was issued in consonance with the Hon'ble Gauhati High Court Principal Seat Notification No. 28 dated 19<sup>th</sup> April, 2021 Notification No. 29 dated 20<sup>th</sup> April, 2021 and Notification No. 30 dated 21<sup>st</sup> April, 2021 which were extended from time to time with modification.

Whereas this Registry with the approval of the senior-most Station Judge had adopted the measures notified by the Principal Seat with certain modifications and additions which were notified vide Notification dated 4<sup>th</sup> May, 2021 and Notification dated 15<sup>th</sup> May, 2021 which have been extended due to prevailing COVID pandemic.

Whereas with the decrease in COVID cases in the State, the Government of Nagaland has begun the process of unlocking in phases from 1<sup>st</sup> July, 2021. The fifth phase of the unlocking process has started from 19<sup>th</sup> August till 2<sup>nd</sup> September, 2021.

Now taking into consideration the phased unlocking of the Government, the Gauhati High Court Kohima Bench shall resume limited physical courts with effect from 31<sup>st</sup> August, 2021 by restricting the entry of visitors.
