1. AGE:-

2. EDUCATIONAL QUALIFICATION:-

- (i) Candidate must be a graduate from a recognize University in any discipline.

3. SELECTION PROCESS:

Stage	Description	Marks
Stage 1: OMR based Written Examination	Written Test may be of 2 (two) hours duration comprising of General English (50 Marks), General Knowledge (20 Marks), Computer Knowledge (10 Marks) and General Aptitude (20 Marks).	100 Marks
Stage 2: Interview	Candidates in the ratio of 1:3 on the basis of performance in the OMR based written test may be called for the Interview.	15 marks

Final select list will be prepared based on the total marks obtained in both **Stage-1** and **Stage-2**.

Note: In case of candidates obtaining equal total marks, one who obtains more marks in the written test will be given preference. Where the marks obtained by such candidates in the written test are same, the candidate who is senior in age will be given preference.

The Gauhati High Court reserves the right to fix cut off marks in the Written Examination.

4. HOW TO APPLY:

- I. Candidates are first required to go to the website www.kohimahighcourt.gov.in, download and take printout of the "Advertisement & Application Form".
- II. Candidates shall fill the Application Form and paste his/her recent passport sized coloured photograph in the given space of the application form and shall sign across the photograph. 4 (Four) copies of the same photograph should be stapled in the top right corner of the application form and the candidate should write his/her name on the reverse of the stapled photographs. - IV. Applications submitted in any other mode, except as indicated, will be summarily rejected without any communication.
- V. The list of candidates with allotted Roll Nos. will be published in the High Court website for reference of the candidates in due course.

5. **FEES:**

Indian Postal Order (IPO)/Demand Draft of Rs. 100/- (one hundred) only payable to the Registrar, Gauhati High Court, Kohima Bench, Kohima, Nagaland should be enclosed with the application form.

7. TERMS AND CONDITIONS:

- I. Merely satisfying the eligibility criteria does not entitle a candidate to be called for the written examination/skill test/interview etc.
- II. Candidates who are already in Government service shall have to produce ""No Objection Certificate" from his/her employer.
- III. The certificate for claim of reservation must be issued by the competent authority.
- IV. No person who has entered into or contracted a marriage with a person having a spouse living or who, having a spouse living, has entered into or contracted a marriage with any person, shall be eligible for appointment to the said posts.
- V. Service of fresh recruits will be governed by the New Defined Contributory Pension Scheme, 2010.
- VI. The admission of candidates at all stages of the selection process will be purely provisional and subject to their satisfying the prescribed eligibility conditions by way of furnishing documentary evidence in support thereof. If on verification at any time before and after the selection process, it is found that a candidate does not fulfil any of the eligibility condition, his/her candidature shall stand cancelled without any notice. Mere calling of the candidates to written examination/skill test/

interview etc. and mere issuance of admit card/ call letter etc. does not necessarily mean acceptance of candidature of any candidate which shall be further scrutinized at every stage and Gauhati High Court reserves the right to reject the candidature of any candidate at any subsequent stage.

- VII. The High Court may decide not to issue admit card/letter etc. to the candidates individually and may decide to call candidates to written examination/skill test/interview etc. by publishing a notification in the official website of the Kohima Bench and notice board of the High Court, Kohima Bench.
